AT OUR CORE, WE HELP THE PEOPLE WE SERVE TO BUILD A MORE SECURE FUTURE. WE UTILIZE COMMUNITY NEEDS ASSESSMENTS AND INPUT FROM COMMUNITY PARTNERS TO ESTABLISH SERVICES. THIS FISCAL YEAR, WCCA SERVED 11,566 INDIVIDUALS FROM OVER 4,000 HOUSEHOLDS. OF THESE MORE THAN 1,200 (11%) WERE OVER THE AGE OF 65 AND OVER 4,800 (41%) WERE UNDER THE AGE OF 18.
